


Vision

While the event also showcases the New Zealand Agritech community, it also enables business to be transacted, innovation to be promoted and a vast array of information transfer.







Fieldays 2023

With our June Fieldays being the first winter event with the borders fully open, we were once again able embrace international visitors at levels reminiscent of pre-pandemic times, featuring 35 international exhibitors and ambassadors from 17 countries around the world. With its reputation for showcasing cutting-edge farming technology, innovative agricultural practices, and a vibrant marketplace, once again Fieldays was able to serve as the ideal platform for everything farming and primary sector related.

Celebrating its 55th anniversary Fieldays provides a place for our exhibitors to showcase New Zealand's agricultural excellence. Focusing on the strategic pillars of Innovation, Education and Globalisation we have grown our Hub initiative to include the inaugural Fieldays Sustainability Hub which sat alongside the Fieldays Innovations Hub, Fieldays

Hauora Taiwhenua Health & Wellbeing Hub, Fieldays Opportunity Grows Here Careers Hub, and the two hubs launched in 2022 - the Fieldays Forestry Hub and Fieldays Digital Futures. The Fieldays Sustainability Hub featured a select number of sustainability-focused organisations and visitors were able to explore sustainable farming research and science, urban and rural waste management, as well as water management and renewable energy.

While it's important to bring in new aspects to the event as it continues to evolve, the tried-and-true features of Fieldays continued to be well-received by our valued exhibitors, and visitors alike. In addition to the event commemorating its 55th anniversary, the Fieldays Innovation Awards also celebrated 55 years of highlighting and supporting innovation in the primary sector. Trends seen in 2023 were related to cyclone response, health and safety on farm, and water testing along with AI farm support, compliance and regulatory apps and programs. The



global financial crisis had also been on the mind of innovators with practical solutions being sought for better efficiency and ways to combat labour shortages across the food and fibre sector. A change in category criteria for the Young Innovator Award will continue to encourage students and school leavers to enter the awards with continued support from Agribusiness in Schools helping drive this initiative. The calibre of this year's entrants was incredibly high and even more outstanding despite the quick turnaround from the 2022 awards. This demonstrates how the innovation eco-system is thriving.

Several changes were made to enhance the customer experience at this year's event, one being the move of the Rural Living Precinct to where the Agri Machinery Precinct had previously been. The primary benefit of this change was to promote better flow of visitors through the event, allowing them to see as much of the exhibition as possible and provide opportunities for growth in our core agri exhibition sites. The Fieldays Bar & Eatery was relocated from its site in the central precinct to the bottom of Gate 2 hill and proved popular for both visitors and exhibitors as a great place to network and connect.

Fieldays has been the cornerstone event of the New Zealand National Fieldays Society since its inception, contributing to our financial success and the heritage of our business. Central to the success of Fieldays are our partners, sponsors, and stakeholders and the role they play. Their support is not confined to the event itself but extends throughout the year. These sponsors are more than financial backers; they are strategic collaborators that share our vision for the future of agriculture in New Zealand. Through their support, Fieldays continues to demonstrate that it is the platform for collaboration and advancement, ensuring that the event continues to evolve, adapt, and lead the way in shaping the future of our primary sector.

Only six months separated the closing of our gates on the 3rd December 2022 and their reopening on the 14th June 2023. Attendees not only increased in numbers but notably there was a substantial rise in visitors from regions like Gisborne, Hawkes Bay, Whanganui, and the Manawātu. The quick turnaround for not only the venue, our partners and sponsors, exhibitors, staff and volunteers was remarkable and evident in the combined gate numbers surpassing 180,000 in a seven month period. This underlines the continued popularity and success of the event.







Over the past year we have activated our three strategic pillars through various initiatives such as:







Innovation

Fieldays is the ultimate launch platform for cuttingedge technology and innovation, this year we showcased 48 finalists in the prestigious Fieldays Innovation Awards and provided them with a platform to launch their innovation globally. In 2023 we had topical entries related to cyclone response, health and safety on farm, water testing, Al farm support, and compliance and regulatory apps and programs.

Education

Education is specifically targeted at the event throughout activations like the Careers, Health and Wellbeing, Forestry, and Sustainability Hubs to inform and educate visitors on essential aspects of the agricultural sector.

This creates opportunities for visitors to learn about the many different career opportunities available in the sector, from hands-on roles in agriculture and horticulture, to technical roles in science and technology, proving that opportunity grows here at Fieldays.

Globalisation

Fieldays 2023 saw the New Zealand International Business Centre once again offer unique networking opportunities as well as support for businesses to grow within Aotearoa New Zealand and internationally.

Representatives from around the world experienced the best of the primary sector from New Zealand and made important new connections.









CONNECTIVITY WINS NO.8 WIRE NATIONAL ART AWARD

Since its inception in 1997, this annual open call for artists and creatives from across Aotearoa has provided a platform for reinventing an everyday farming product into art. The Awards play a crucial role in fostering a stronger connection between urban and rural communities.

Hosted by Waikato Museum Te Whare Taonga o Waikato and supported by the Society the competition saw over 25 artists rise to the challenge of transforming this iconic Kiwi farming product, No.8 wire, into art and compete for a share of nearly \$10,000 in prizes.

Hawke's Bay artist Ricks Terstappen took out the top prize for this work aptly titled "Connectivity" which stands as a compelling metaphor for the unity and strength of rural communities.

Second prize was awarded to Jeff Thomson and Bev Goodwin for their piece "Cyclonic" and third place went to John McKenzie for "641E9372".

For the second year in a row, Heather Olesen took home the Chair's Choice Award for her piece called "In Case of Emergency...Break Glass".



MYSTERY CREEK EVENTS CENTRE

Since the removal of COVID restrictions in mid-2022 there has been a surge in bookings and the return of larger events to Mystery Creek Events Centre.

This serves as a positive sign for our community and the economy as a whole.

Northern Easter Camp

After a three-year hiatus due to COVID, the Northern Easter Camp made a triumphant return from 6th to 10th April. More than 5,000 teenagers and young adults flocked to the Mystery Creek Events Centre for a five-day, four-night camping extravaganza. The event featured a wide array of activities, including a mesmerising laser light show, lively dance parties, thrilling sports, and even a muddy adventure pit, complete with a water slide in a section of the site most famously used for the Fieldays Tractor Pull Competition.

NZMCA Motorhome, Caravan & Leisure Show

During the third weekend of September, the Mystery Creek Events Centre hosted the NZMCA Motorhome, Caravan & Leisure Show, attracting an impressive 20,000+ visitors. This marked the 9th year of the show's presence at the venue, drawing motorhome and caravan enthusiasts from across the country. Many attendees chose to set up camp on the premises, creating a vibrant mini-village atmosphere, with an estimated count of over 1,300 motorhomes and caravans making the event site their temporary home for two days.

STAFF TRAINING AND DEVELOPMENT

Staff training and development are essential components of a successful and forward thinking organisation. Effective training and development programs not only equip staff with the tools they need to excel in their current roles but also prepare them for future challenges and opportunities.

As part of our new learning and development framework, every six months we undertake visits to our valued exhibiting customers. Visiting our customers at their workplaces enables the team to gain insight into their business and the work they are doing for the primary sector. These visits help us identify what our exhibiting customers value about Fieldays and allow us to gather feedback for potential improvements.

Thank you to Livestock Improvement Corporation (LIC), Hansa Products Ltd and Gallagher Group for hosting the team in March.

The team has also taken on another substantial initiative via The Disney Institute, which serves as the professional development and training division of The Walt Disney Company. Renowned for its exceptional customer service and employee training programmes, the team participated in the online programme called Disney's Approach to Quality Service. This programme focuses on the principles of delivering exceptional customer service, emphasising the importance of exceeding customer expectations, creating memorable experiences, and building customer loyalty.



SUPPORTING EDUCATION THROUGH INTERNSHIP OPPORTUNITES

The New Zealand National Fieldays Society, through its internship programs, plays a pivotal role in fostering growth and development with the education pillar at the heart of its mission.

In July we welcomed Briley Morgan, who joined us for a four-month tenure dedicated to a research project. This initiative seeks to explore strategies for infusing sustainability into the very fabric of our Society. Our comprehensive approach encompasses all stakeholders, including staff, contractors, suppliers, volunteers, members, sponsors, the Board, committees, and our Constitution.

Growing in up Papamoa and then the Waikato, Briley comes from a farming background, and first visited Fieldays when 11 years old.

"Interning at the Society has been eye-opening, in terms of the range of learning opportunities and the scope of work the Society does, which is ongoing and includes a lot more than meets the eye and it's not just a four-day event," said Briley.





VOLUNTEERS

Volunteers are integral to the New Zealand National Fieldays Society, contributing significantly to the seamless organisation and successful implementation of the Fieldays event, along with various other aspects of the Society's operations undertaken throughout the year. Whether it's the group of Predator Free Volunteers who arrive on Friday mornings to assist with the programme that works at protecting our flora and fauna in and around the site, riparian planting programmes, painting fences and garden boxes, helping with other Society events the roles and responsibilities and tasks can be diverse.

However, one thing that unites them all is their dedication and willingness to support the Society which plays a crucial role in fostering an unwavering sense of community. We are forever grateful for the efforts of our volunteers and realise that without them we would not be able to achieve what we do.

VOLUNTEERING WAIKATO

The return of Fieldays to June, saw 157 volunteers back doing what they enjoy most, greeting and helping our visitors, catching up with their peers over a hot cuppa, and most of all, supporting the Society to deliver another successful event.

The Society's investment and rollout of Rosterfy in 2022 paved the way for improved interaction within our volunteer community for Fieldays 2023 due to a better understanding of the system and greater flexibility across roles and available shifts. We didn't quite manage to fill all available shifts (521 shifts across the four days); however, with 92% filled, this was considered a great effort.

The Society was delighted to have the support of Stoney Creek who provided top quality outer garments for our volunteers enabling them to stay warm and dry and look the part as a collective team after many years of various styles of uniform.

SOCIETY MEMBERS


The Society has three types of membership starting with **Volunteer Membership**, which is open to any volunteer who has assisted the Society from time to time and is offered membership by the Society Board. **Financial Membership** is available to those who choose not to volunteer but would still like to have a connection with the Society and lastly, **Honorary Life Membership**, which is awarded to Volunteer Members by the Society's Board and recognises the member's outstanding service and contributions to the Society. The number of Honorary Life Members at any one time does not exceed 20.




SUSTAINABILITY AT FIELDAYS 2023

Our unwavering dedication to sustainability in our operations and events remains a central focus for the Society. We are continually striving to refine our practices to be more environmentally friendly, and have taken significant steps to broadcast our stance on the urgent need for collective action to curtail our impact on the environment and confront the challenge of climate change.

In recent months, the Society has seen significant progress in the sustainability sector, marked by the initiation of several projects and the ongoing support and effective maintenance of others.

The Society has worked hard for over a decade to make the Fieldays event as sustainable as possible, and this year we are proud to share that we have achieved the following at Fieldays 2023:



Sixteen cubic metres of milk bottles (#2 plastic) were repurposed

Eight hundred and eighty kilograms of aluminium cans were collected

Soft plastics, tetra paks, and coffee cups, collected for recycling

Food scraps, compostable packaging, and coffee grounds were taken to a local commercial composter

All coreflute materials were generously donated to a local community club, to reuse

Plastics # 1 and 5, timber, glass, and metal were recycled through Waste Management

United Nations Sustainable Development Goals

We continue to intergrate the Sustainable Development Goals (SDG's) into our Society practices aligning with our core business.













The introduction of the first-ever Sustainability Team at Fieldays, comprising of volunteers, has revolutionised our sustainability efforts. The team engages with exhibitors, to educate them about sustainable practices and conduct various surveys to calculate our carbon footprint.

An exhibitor generously donated Rimu trees they had used on their site to the Society. These trees will be planted in restoration areas at Mystery Creek Events Centre.

Virtual workshops were conducted leading up to the event with Food Court vendors, Fieldays Pantry exhibitors, and other participants, focusing on waste management practices at Fieldays. Valuable feedback from these sessions prompted the implementation of a back-of-house recycling system for Food Court vendors, resulting in an effective and efficient waste management process.





Commitment to Sustainability Award at Fieldays

Pure by the Barrelman, a Fieldays Pantry exhibitor was recognised for their dedication to the environment taking out the Commitment to Sustainability Award for their mission to be 100% sustainable. Pure by the Barrelman, owned and operated by husband-and-wife team Darryn and Tania Candy, repurpose oak wine barrels in their entirety to create a range of eco-friendly products, including platters, plant stands, and furniture. Any leftover materials are donated to local restaurants for use in their smokers. Their commitment to minimising waste extends to their site packaging and display props, which are reinforced using recycled wool blankets and coffee sacks.

Repurposing vegetable seedlings from the Fieldays Sustainability Hub

Demonstrating genuine collaboration and community engagement, NZNFS staff members Steve Chappell, Beth Jobin, Kelly Lloyd, and Janine Monk, joined by orchard workers from the Ngaati Haua Iwi Trust and the Community Advisor for the Matamata-Piako District Council, planted donated vegetable plants at the Rukumoana Marae near Morrinsville. These 150 plants, originally featured at the Fieldays Sustainability Hub site, highlighting the organisation's dedication to sustainability. This serves as a testament to the positive outcomes that can arise from such collaborative efforts, making a meaningful impact on local communities.

SUSTAINABILITY IN THE COMMUNITY

The past few months have been fruitful for the Society in the sustainability and community space, with several projects kicking off, and others continuing to be supported and well-maintained.



Mystery Creek Community Environmental DNA (eDNA) initiative

Supported by the Society, this is a concerted effort to engage in the Wai Tuwhera o te Taiao – Open Waters Aotearoa programme, which supports connections with science and local environments. This project leverages environmental DNA (eDNA) to inform and unite our community in safeguarding our waterways and the broader environment.

Benchmark water testing was conducted at the Mystery Creek Events Centre jetty on the Waikato River and at three other locations along the Mystery Creek stream. Simultaneously, AquaWatch installed their innovative 'Waka', enabling real-time monitoring of water quality.

With the insight from testing, we aim to collaborate to form a five-year plan for the restoration of our local waterways.

To date, the Society and the New Zealand Landcare Trust held workshops with local stakeholders to discuss the results and the long-term trajectory of the project. During Fieldays 2023, the Environmental Protection Authority organised daily workshops in the Fieldays Sustainability Hub, showcasing this project as an exemplar of best practices on a national and global scale, while providing insights into what other communities are busy trying to achieve.



Mystery Creek Community Gully Restoration

The Waipa District Council Heritage Fund has allocated funds to facilitate a Biodiversity Management Plan for the Mystery Creek Community Gully Restoration Project. This includes the restoration efforts focused on the gullies around various businesses within the Mystery Creek area and Waipa District Council land. A report outlining the project is currently being written. The project is expected to take anywhere between 5 to 10 years.

A colouring-in competition was held between local rural schools to find a piece of artwork for the front cover of this report. The winner has been announced, and because of the high calibre of art received, the other entries will be showcased on pages throughout the report.



Mystery Creek Predator Free Community Hub

Since the project started nearly three years ago we now have 343 traps out in the community that are checked regularly.

Uniforms donated to Ark Quest Trust

In September, Jan Dean, representing Ark Quest Trust, collected three large boxes and six sacks filled with expired branded uniforms. These donations will accompany her to a small rural Kenyan village in July 2024. Recycling expired branded uniforms aligns with our sustainable practices by reducing textile waste and will serve as an essential item for these farm workers.

Clint is an Agribusiness Consultant with AgFirst Waikato. He started the role in June 2018 following seven years in the dairy industry and three years as a rural bank manager. Clint became involved with the Society as a recipient of the inaugural Fieldays Future Leaders programme scholarship in 2015. Clint has held governance roles within the Society since 2018.

Graeme Austin | Board Member

Graeme graduated Massey University with a degree in Agricultural Science. He has since cultivated 35 years of commercial experience and involvement in NZ agriculture, including agricultural consultancy, rural finance and sales and marketing in the seed industry. He currently works with PGG Wrightson Seeds as National Sales Manager for one of their seed brands. Graeme sits on several different boards and is also a member of the Institute of Directors and NZIPIM (NZ Institute of Primary Industry Management).

Mike Chapman | Co-opted Board Member

Mike is Chair of New Zealand Ethical Employers Incorporated and is Chair of the Food & Fibre Capability Leadership Group and Forum.

Mike assists other organisations with ethical employment, strategy, organisational structure, government relations and labour issues. Mike publishes a monthly blog on topical and sector issues. Previously Mike was Chief Executive of Horticulture New Zealand, of NZ Kiwifruit Growers Incorporated, of Kiwifruit New Zealand and was an inaugural Director of Kiwifruit Vine Health Incorporated.

Jo Finer | Co-opted Board Member

Jo is Chief Executive at the Institute of Primary Industry Management and an Associate Director with Southern Pastures LP. She previously worked at Fonterra where she led stakeholder engagement and policy, global regulatory affairs, and food safety and quality. Alongside her management experience, Jo has spent time dairy farming, both as a share milker and on the family farm.

BoardPro

The Society have used BoardPro since early 2018, a cloud-based governance reporting software, which provides an efficient and concise recording platform of all board and board committee meetings delivering a consistent format and process for effective governance of the Society. BoardPro enables governance documents to be accessible to all board members and management from anywhere for ongoing reference. Using BoardPro eliminates the need to produce printed material, which meets the Society's ongoing focus to reduce waste.

Relationship between Management and the Board

The Board and the Society work in partnership to govern and operate in accordance with the fundamental principles and agreed mission, objectives and values; recognise and respect the views, efforts and contributions of members; and act in accordance with the current strategic plan, operational plan, and other policies of the Society. A Board Charter sets out the governance requirements for the Society and provides terms of reference for the Board including responsibilities and authority. The Charter is read in conjunction with the Constitution and Board policies.

The CEO is appointed and is accountable to the Board, through the President for the successful operation of the Society. The CEO reports directly to the President of the Society who acts on behalf of the Board in the capacity of Society employer. The Board delegates to the CEO the authority to manage the business and affairs of the Society and the ability to sub-delegate to other levels of management including but not limited to the Leadership Team. The Board sets annual performance targets for the CEO, based on the strategic plan.

Members of the Board have been elected and co-opted to provide leadership, determine strategic and financial goals for the Society and ensure their implementation. The functions of the Board are to complement that of management.

Composition of the Board and Succession

The Board may have a maximum of ten members made up of four elected members, plus President, Vice President and not more than three coopted members. The Board should be mindful of succession planning to ensure that institutional knowledge of the Board is retained; recognising the composition of the Board may change at each election. The Board should from time to time, determine any skill gaps to ensure thorough co-option, where necessary that the Board remains robust, with a complete set of skills and competencies. The Board should also plan to ensure that the composition should be diverse, where the individual and collective board members offer a wide and varied skill set.

Committees

The Board has the power to appoint board committees who report back to the full board. Currently, the Board has four permanent committees each with individual terms of reference. These include the Finance, Audit and Risk Committee: the Assets and Facilities Committee: the Structure Committee and the Events Committee. A full review of all board policies is driven by the Finance, Audit and Risk Committee before being ratified by the Board. All policies are reviewed annually. In addition, the Board may, from time to time, establish other committees. Unless explicitly empowered by the Board, board committees cannot make binding board decisions, or speak for the Board. For the most part, the function of board committees is to make non-binding recommendations to the Board.

Conflicts of Interest

The Board expects members both Individually and collectively, to act ethically and in a manner consistent with the values of the Society. Each board member will minimise the possibility of any conflict of interest with the Society by restricting involvement in other business that would likely lead to a conflict of interest. Where conflicts of interest do arise, board members will excuse themselves from relevant discussions and will not exercise their right to vote in respect of such matters.

FINANCIAL OVERVIEW

Following on from the last financial year, The New Zealand National Fieldays Society continued with a strategy focusing on cost-containment and close monitoring of non-essential expenditure.

2023 Finance Report

The Society's 2023 financial results include two Fieldays events in the same financial year. This was due to the postponement of the June 2022 event to November 2022, in response to Covid restrictions. This created a significant increase in both revenue and expenditure when compared with the 2022 financial year, which didn't contain a Fieldays event.

The Board has approved a budget for the 2024 financial year prepared by management, which includes a forecast for the next 12 months. The budget shows a return to the traditional event cycle for the organisation.

After taking account of reasonable possible downsides, the forecast indicates that the Society can expect to continue to operate within available cash levels and debt facilities, while returning a forecasted profit.

The Board and management remain focused on the Society's liquidity and expect to manage business operations while maintaining adequate cash flow through the execution of:

- Reducing costs and seeking further efficiencies across the organisation.
- Deferral of all non-critical or discretionary operating and capital expenditure.
- The ability, if required, to divest significant assets of the Society to ensure we can meet debt liability.

Total income for the year was \$16.9 million, an increase of \$15.5 million from the prior year. This increase is a direct result of running two Fieldays events in the 2023 financial year and against the Covid-interrupted 2022 year.

The Society's revenue includes sponsorship income, event income from both Fieldays and Mystery Creek Events Centre in conjunction with property income (from assets under lease arrangements).

Total expenditure for the year was \$13.9 million, an increase of \$8.5 million, which primarily was the cost of running two Fieldays events. Salaries and wages increased with recruitment of additional staff, permanent and fixed-term required for Fieldays. Property expenses increased to \$0.9 million with expenditure to cover some prior years deferred maintenance.

In October, the Society drew down additional term debt of \$750,000 and increased the overdraft limit by \$750,000. The purpose of the debt was to refinance historical losses out of the overdraft and into long-term debt.

Based on the forecast the Board and management believe that it remains appropriate to prepare the financial statements on a going concern basis. There is a reasonable expectation that the Society will comply with the requirements of the debt facilities for the next twelve months and based on the forecasted assumptions the Society should return to profitability.


