# Fieldays® Pre-Release Booking Terms and Conditions

## 1.0 Definitions

- 1.1 The following meanings will be given to these words in the below Exhibiting Terms and Conditions:
  - a) Exhibitor Guidelines means the separate document containing the additional terms and conditions specific to each of the Fieldays Precincts.
  - Exhibitor Portal refers to an online portal facilitating exhibitor Site applications and containing essential information for exhibitors.
  - c) Fieldays means the Fieldays event.
  - d) Food Vendor refers to an exhibitor that is selling ready to eat food and/or beverages to patrons at the event in one of the designated Food Courts or Bar & Eatery.
  - General Applications refers to the public application process for Fieldays sites.
  - Main Exhibitor refers to an exhibitor who has been allocated and invoiced for the site in the first instance.
  - g) Precinct refers to a specific area of the Precinct Event Grounds as determined by the Society.
  - Site refers to a specific area of the MCEC Event Grounds that is allocated to you as an exhibitor, including, in relation to
    a Sublet Exhibitor, the site allocated in the first instance to the Main Exhibitor.
  - i) Sublet Exhibitor refers to a separate exhibitor sharing a Site with the Main Exhibitor.
  - j) You and Your means the person or entity that is the exhibitor at the Fieldays event.

#### 2.0 Overview

- 2.1 The Pre-Release booking system allows Main Exhibitors who held a Site at the previous Fieldays event within Agribusiness Indoor, Agribusiness Outdoor, Motor Vehicle Precinct, Heavy Equipment Precinct or Rural Living Outdoor the opportunity to re-book their Site(s) prior to General Applications for the event going live.
- 2.2 The Pre-Release booking system is renewable on an annual basis, and is subject to terms, conditions, and criteria.
- 2.3 The Society reserves the right to relocate a Pre-Release booked site when required to accommodate a New Zealand National Fieldays Society Inc. or Fieldays Partner and/or Sponsor.
- 2.4 All Pre-Release Booking applications must be completed in full online in the relevant years Exhibitor Portal by the deadline date stated on the Fieldays website. Verbal, tentative and/or pencil bookings will not be accepted under any circumstance.
- 2.5 Applications for the Pre-Release Booking System are assessed each year on a case-by-case basis. The Society reserves the right to offer, revoke, and/or refuse the Pre-Release site booking at its sole discretion.
- 2.6 The Society will respond to all Exhibitors regarding their application outcome by the end of the application review period.
- 2.7 Accepted Exhibitors must complete their formal site acceptance within the relevant years Exhibitor Portal no later than 5pm 1 October (the year preceding the event).
- 2.8 The Pre-Release Booking System is not available to customers who exhibited within the Fieldays Hauora Taiwhenua Health & Wellbeing Hub, Rural Living Indoor (marquee), The Pantry or Food Vendors sites. Sublet Exhibitors and Innovation Award entrants are also ineligible

## 3.0 Criteria for the Pre-Release Booking System

- 3.1 To be eligible for acceptance exhibitors must:
  - a) have been the Main Exhibitor in one of the eligible Precincts at the previous Fieldays event.
  - b) be wanting to retain some or all of the Site(s) held at the previous Fieldays event or be interested in expanding their current location (not looking to relocate their Site(s)).
  - c) have a good payment history, with no outstanding fees.
  - have a good compliance history e.g., no unsanctioned sublets, compliance with the alcohol management policy, vehicle movement rules and pack-out deadlines.
  - e) have a product offering and planned site design that meets the Exhibitor Guidelines specified for that precinct.

### 4.0 Pre-Release Booking System Payment Terms

- 4.1 There is a \$450 + GST booking fee per site for Pre-Release Booking sites.
- 4.2 The Pre-Release booking fee is non-refundable, except for:
  - a) If the Society requires the Exhibitor to relocate their Site due to the positioning of a Partner and/or Sponsor, or Fieldays strategic initiative, a full refund of the Pre-Release booking fee will be offered.
  - b) If the Exhibitor declines their formal Pre-Release site offer prior to the date specified in their Site offer email, a full refund of the Pre-Release booking fee will be offered. If the exhibitor does not decline in writing before this date, they will not be entitled to a refund.
  - c) If the Society determines that it is necessary to cancel Fieldays, the benefits of the Pre-Release system will be transferred to the following event.
- 4.3 All Pre-Release booking fees must be paid in full by 20 September (the year preceding the event).
  - Those not paid by the deadline will be automatically declined and the Exhibitor will need to re-apply when General Applications open.
- 4.4 The booking fee is waived for Fieldays Partners and Sponsors at the discretion of the Society.
- 4.5 All site fees will be invoiced the first week of December (the year preceding the event) and will be due in full by 20 January (the year of the event).

## 5.0 Forfeiture for Non-Payment

5.1 If the exhibitor fails to pay invoices in full for the Pre-Release Booking fee(s) and/or the site fee(s) by the respective due dates, then the exhibiting right and renewal option for the site(s) is forfeited and the site(s) may become available for allocation to and/or reservation by another exhibitor.

#### 6.0 Society's Reservation of Rights

- 6.1 The Society reserves its full rights, without notice and at its sole discretion, to:
  - a) offer, revoke, and/or refuse Pre-Release Booking System approval;
  - b) accept or decline any application;
  - waive, extend, and/or redefine the availability of and application for the Pre-Release Booking System;
  - d) change, amend and/or alter the exhibiting conditions and prospectus;
  - e) change, amend, and/or alter the terms and conditions;
  - f) alter or remove sites for reasons including but not limited to:
    - i) changes to the size and/or layout of the exhibition area; or
    - ii) redevelopment of any area(s).
